## GENERAL TERMS OF EXHIBITING

### 1. Organizer

The fair is organized by DMK Vall 042 Ltd. Varaždin, I. Cankara 9, 42000 Varaždin, Croatia.

### 2. The right of participation

The event will host exhibitors from production, trading and catering companies, public institutions, tourist organisations, crafts and family farms, and other legal entities and organisations from the fields of hunting, fishing, tourism, forestry, food production and ecology. The layout of the exhibition space is left to organizer's discretion.

### 3. Application and participation

Exhibitor interested in participating at the fair concludes a Contract on lease of space with the organizer by filling in the Exhibition application form.

The application deadline is September 25th, 2022.

Organiser confirms the acceptance of the application form and invoice service application fee of 400,00 KN / 53,09 € (+ 25% VAT) which is non-refundable.

Exhibiting space will be reserved only upon receipt of payment.

Upon the expiry of the application deadline and once the distribution of exhibition space has been made, the exhibition layout is delivered to the exhibitors. The exhibitor is obligated to exhibit during the entire duration of the Fair, and responsible personnel must at all times be present in the exhibition space.

Withdrawal from the Fair prior to its conclusion is not permitted.

### 4. Cancellation

Should the exhibitor, due to unforeseen circumstances, propose in written form, the withdrawal of his Application form to the organizer, up to 15th of Septmeber 2022, the organizer will accept the withdrawal with no additional costs. In case cancellation is made in period 20th-30th September, exhibitor will be invoiced with 50% of the contractual value of the exhibition space unit. The organizer cannot accept any cancellations of later date, and the applicant will be invoiced with ordered space as well as all other services performed up to that point. If the organizer is forced to temporarily or even for a long time empty one or more exhibition spaces due to force majeure or for some other reason, which is not within his competence, the exhibitor does not have the right of access or cancellation, as well as the setting of some other requests, especially not the right to claim damages from the organizer.

If the organizer is forced to cancel the Fair after September 30th due to force majeure or for some other reason, which is not within his competence, the exhibitor does not have the right to request compensation from the organizer, and the organizer will implement the same according to the possibilities and costs incurred in preparation of the Fair until the cancellation date. In the event of cancellation of the Fair by September 30, the Organizer will refund the amount paid to the exhibitor, which does not include the amount paid of the Application fee (see item 3).

### 5. Terms of payment

By signing the Application form and General Conditions, the exhibitor accepts the exhibition prices, as well as the obligatory costs set in the application form. The prices are to be paid in Croatian Kuna, according to the fixed exchange rate of the Croatian National Bank 1 €=7,53450 KN. VAT shall be added to all the listed prices. Upon sent application form, Organizer will send invoice for registration with amount 400,00 KN / 53,09 € (+ 25% VAT) which needs to be paid imidiately. In September, based on the received Exhibition application form, the organizer will issue an offer/invoice to the exhibitor which needs to be paid until 20th of September. Also, the organizer will deliver to the exhibitor the calculation of any possible subsequently ordered and performed services, payable within 7 days from the date of receipt. Should the exhibitor fail to make the payment in the designated currency, interests will be charged. The exhibitor is entitled to appeal to the delivered invoice within 7 days from the date of receipt.

### 6. Fair services

Exhibition space is ordered according to conditions from

the price list. The exhibitor may order a basic exhibition space unit and, if necessary, additional equipment. In case exhibitor has his own equipment and doesn't need anything except floor with carpet, he can also order unequipped exhibition space unit upon request.

Each partially used square meter counts as a full 1m2. The organizer allocates exhibition space units in accordance with the basic concept. The price of exhibition space unit includes a specific number of exhibition accreditations, exhibition space insurance, stands and aisles maintenance, organizer's intermediation in advertising and public relations matters, participation in profession related lectures and fair events.

The organizer installs and equips the exhibition space units in accordance with the terms set in the Application form and the price list. The stand is installed in accordance with the Octanorm system with infill walls, 250 cm high. The entire floor surface of the exhibition space unit is covered with carpet.

The organizer is obligated to deliver the stand and the equipment 20 hours prior to the commencement of the show. By initiating the arrangement of the exhibition space unit, the exhibitor indicates his acceptance of the stand and the acceptance of responsibility for the stand equipment. Clearing of the exhibition space may commence upon the official conclusion of the show, once the visitors have left the premises. In case of disappearance of stand materials and equipment, the exhibitor is obligated to reimburse the organizer for damages, in accordance with the organizer's price list.

The exhibitor may not allocate his exhibition space unit to a third party without the consent of the organizer. Complaints about possible deficiencies of the exhibition space unit must be reported to the organizer prior to the commencement of the fair. Subsequent complaints will not be accepted. Should the exhibitor fail to accept the ordered space 12 hours prior to the commencement of the show, without previously notifying the organizer, the organizer is entitled to dispose with the space in question from such time onwards, and the exhibitor is charged with the entire amount of exhibition space unit rent and other ordered services.

### 7. Security and insurance

The organizer ensures a night guard for the exhibition hall (indoor only) during the non-working hours of the fair, but the exhibitors may order additional surveillance of their exhibition space unit and exhibits and, via organizer or the Insurance Bureau, insure the exhibition space unit and exhibits. The organizer does not accept responsibility for uninsured exhibits and other property, and the occurring damages are charged to the exhibitor.

### 8. Exhibition badges – accreditations and parking tickets

The exhibitor is entitled to one free exhibition accreditation per every 6m2 of the pavilion space. If the designated number of accreditations is insufficient, additional accreditations may be ordered in accordance with the price list. Exhibition accreditations are valid from the first day of the show until the last day of clearing.

Each exhibitor is also entitled to one parking ticket. The exhibitor with a stand that exceeds the total area of 40m2 may receive two additional parking tickets on request. Parking tickets must be shown when entering the exhibitors' parking lot and left visible under the windshield.

### 9. Exhibitor catalogue and advertising

The organizer issues a Catalogue of fair exhibitors. Inclusion in the catalogue is mandatory. The organizer will enter the basic information form the Application form. The exhibitor is responsible for the content entered into the catalogue and the content of adverts, and accordingly, the organizer does not accept responsibility for possible inaccuracies and incompleteness. Advertising materials must be delivered by September 28th, 2022.

### 10. Sales of merchandise

In accordance with valid laws and regulations, the fair allows the exhibitors to make direct sales in their exhibition stands in accordance with valid regulations.

### 11. Final provisions

Should any disputes arise between the exhibitor and the organizer; both parties agree to comply with the decision of the court of competent jurisdiction in Varaždin
