## GENERAL DISPLAY CONDITIONS

### 1. Organizer

The trade fair is organized by Zelendvor turizam d.o.o., Grofova Bombelles 2, 42206 Petrijanec, Croatia.

### 2. The right to participate

The fair is open to manufacturers, trading and service companies, public institutions, tourism organizations, craft businesses, family farms, as well as other legal entities and associations operating in the fields of hunting, fishing, tourism, forestry, food production, and environmental protection.

The allocation of exhibition space is determined solely by the organizer.

### 3. Application and participation

Participation in the fair is governed by an agreement concluded between the exhibitor and the organizer through the Exhibition Application Form. These General Terms and Conditions of Exhibiting form an integral part of the application. The deadline for submitting the application is 4 September 2026.

The organizer will confirm acceptance of the application. An application is considered accepted upon the organizer's confirmation and receipt of the Exhibitor Registration Fee of EUR 125 (VAT included), payable to the organizer's IBAN: HR3524840081135246494. This fee is non-refundable in the event of cancellation by the exhibitor. Exhibition space will be reserved only after payment has been received.

Once the application deadline has passed and the exhibition space has been allocated, exhibitors will receive the final exhibition floor plan.

Exhibitors are required to display the registered exhibits throughout the entire duration of the fair, and a responsible representative must be present at the exhibition stand at all times.

Exhibitors are not permitted to dismantle or vacate their exhibition stand before the official closing of the fair. In the event of early departure, the exhibitor will be charged a fee of EUR 150 (VAT included) for non-compliance with the fair's opening hours.

### 4. Cancellation of participation

If, due to unforeseen circumstances, an exhibitor submits a written request to withdraw their application no later than 25 August 2026, the organizer will accept the cancellation without any additional charges to the exhibitor.

If the exhibitor cancels their participation no later than 15 days before the opening of the fair, the organizer will also accept the cancellation. In this case, the exhibitor will be invoiced for 30% of the agreed exhibition space fee to cover preparation costs.

Cancellations submitted after this deadline cannot be accepted. In such cases, the exhibitor will be invoiced for the full cost of the reserved exhibition space, as well as for all services provided up to that date.

Should the organizer, due to force majeure or other circumstances beyond its control, be required to temporarily or permanently vacate one or more exhibition areas, the exhibitor shall not be entitled to withdraw from the agreement, cancel participation, or make any other claims, including, in particular, claims for compensation or damages against the organizer.

### 5. Terms of payment

Upon acceptance of the Exhibition Application Form and receipt of the registration fee of EUR 125, the organizer will issue the exhibitor an invoice for the exhibition space rental. The exhibitor is required to pay either the full amount or at least 50% of the total amount no later than 7 days before the opening of the fair.

Following the conclusion of the fair, the organizer will issue an invoice for any additional services ordered and provided during the event. Payment is due within 7 days of receipt of the invoice.

### 6. Fair services

Exhibition space is booked in accordance with the conditions set out in the price list. Exhibitors may choose between unfurnished exhibition space or standard exhibition space and may order additional equipment if required. Exhibitors wishing to use their own exhibition equipment must notify the organizer in advance and obtain approval. Each commenced square metre will be charged as one full square metre. Exhibition space is allocated by the organizer in accordance with the overall exhibition layout.

The exhibition space rental fee includes a designated number of exhibitor passes, security for the exhibition premises, cleaning of exhibition stands and aisles, promotional and public relations support provided by the organizer, and participation in the fair's professional presentations and accompanying programme.

The organizer will install and equip the exhibition space in accordance with the conditions specified in the Exhibition Application Form and the price list. Standard exhibition stands are constructed using the Octanorm modular system with wall panels and have a height of 250 cm. The entire exhibition area is covered with blue carpet. The stand fascia includes block lettering with a height of 15 cm and a maximum length of 196 cm, positioned on one open side of the stand.

The organizer will hand over the exhibition stand and equipment no later than 20 hours before the opening of the fair. By commencing the setup of the exhibition stand, the exhibitor acknowledges receipt of the stand and assumes responsibility for all stand equipment. Dismantling of exhibition stands may begin only after the official closing of the fair, on Sunday, 4 October, at 5:00 p.m. In the event of loss of or damage to stand materials or equipment, the exhibitor shall compensate the organizer in accordance with the organizer's price list.

The exhibitor may not assign or sublet the exhibition space to another party without the organizer's prior written consent. Any complaints regarding deficiencies in the exhibition space must be reported to the organizer before the opening of the fair. Complaints submitted after the opening of the event will not be accepted.

If the exhibitor fails to occupy the reserved exhibition space at least 12 hours before the opening of the fair without prior notice to the organizer, the organizer reserves the right to reallocate the space. In such cases, the exhibitor remains liable for payment of the full exhibition space rental fee and all services ordered.

### 7. Safekeeping and insurance

At the close of each exhibition day, the organizer will provide overnight security at the entrance to the exhibition hall. Exhibitors may additionally arrange individual security for their exhibition stand and exhibits through the organizer, or obtain insurance for their exhibition space and exhibits through an insurance provider.

The organizer accepts no liability for exhibits or other property that has not been insured. Any loss or damage incurred shall be the sole responsibility of the exhibitor.

### 8. Exhibitor cards - accreditations and parking tickets

Each exhibitor is entitled to one complimentary exhibitor pass for every 6 m<sup>2</sup> of exhibition space booked. If the allocated number of passes is insufficient, additional exhibitor passes may be purchased according to the current price list. Exhibitor passes are valid from the first day of stand construction until the final day of dismantling and must be worn at all times during the fair.

Each exhibitor booking a minimum of 9 m<sup>2</sup> of exhibition space is entitled to one parking pass. Exhibitors with exhibition stands exceeding 40 m<sup>2</sup> may, upon request, receive two parking passes. Parking passes must be presented when entering the exhibitors' parking area and displayed in a clearly visible position beneath the vehicle's windscreen.

### 9. Sale of goods

In accordance with applicable laws and regulations, the fair is a sales event, and exhibitors are permitted to sell their products directly from their exhibition stands in compliance with all applicable legal requirements.

Exhibitors are solely responsible for complying with all applicable laws and regulations. Any penalties imposed by the competent authorities due to non-compliance shall be borne entirely by the exhibitor, including any costs or liabilities that may be incurred by the organizer as a result.

### 11. Photographing

The organizer has the right to photograph or record the exhibition spaces and use the material for its own needs or for general use.

The exhibitor waives all copyright claims.

### 12. Final provisions

In the event of a dispute between the exhibitor and the organizer, the parties submit to the decision of the competent court in Varaždin.
